Stacey Jordan, Chief Financial Officer, gave an overview of the request.

## 23-ORD-28 AN ORDINANCE, AS AMENDED, SAID ORDINANCE MAKING APPROPRIATIONS FOR

# THE FISCAL YEAR COMMENCING JULY 1, 2023, AND ENDING JUNE 30, 2024, FOR PETERSBURG PUBLIC SCHOOLS.

i. A public hearing on an ordinance to amend and re-adopt the Petersburg City Code to Rescind Section 118-94.

**BACKGROUND:** In 2004, the State Code was amended to invalidate local ordinances adopted prior to July 1, 2004, pertaining to possession and transportation of firearms unless expressly authorized by State Code. The City of Petersburg had previously adopted Section 118-94 of the City Code prohibiting the possession and transportation of weapons including firearms by taxicab drivers. This section is not expressly authorized by the state code and requires rescission in order to be in compliance with the statute. The issue was brought to the attention of the City by the Virginia Citizens Defense League.

**RECOMMENDATION:** Adopt the ordinance.

Anthony Williams, City Attorney, gave an overview of the request.

Mayor Parham opened the public hearing for public comments.

Seeing no hands, Mayor Parham closed the public hearing.

Council Member Myers made a motion to approve the ordinance to amend and rescind. Council Member Jones seconded the motion. The motion was approved on roll call vote. On roll call vote, voting yes: Jones, Smith-Lee, Myers, Westbrook, Hill, and Parham; Absent: Cuthbert

# 23-ORD-29 AN ORDINANCE TO AMEND AND RE-ADOPT THE PETERSBURG CITY CODE TO RESCIND SECTION 118-94 PERTAINING TO POSSESSION OF WEAPONS BY TAXICAB DRIVERS.

- **PUBLIC INFORMATION PERIOD:** A public information period, limited in time to 30 minutes, shall be part of an Order of Business at each regular council meeting. Each speaker shall be a resident or business owner of the City and shall be limited to three minutes. No speaker will be permitted to speak on any item scheduled for consideration on the regular docket of the meeting at which the speaker is to speak. The order of speakers, limited by the 30-minute time period, shall be determined as follows:
  - a) First, in chronological order of the notice, persons who have notified the Clerk no later than 12:00 noon of the day of the meeting,
  - b) Second, in chronological order of their sign up, persons who have signed a sign-up sheet placed by the Clerk in the rear of the meeting room prior to the meeting.

Kaya Pope, 2752 Meadowbrook Street stated that she is presented to speak on the many people who are unhoused and cannot receive mail. She stated that P.O. Box and having it sent to the post office can be difficult for these people. She stated that she would like to see the creation of a free mail service for Petersburg Unhoused Population. This service would provide a stable address for those unhoused.

Paula Chester, 1013 Oakmont Drive, stated that she has concerns about the repairs that are being done on Bridge 36. She stated that she is wondering has it been considered to repair when it floods at the train track when it rains. She stated that she would like to know is VDOT considering this repair.

Mayor Parham asked Mr. Williams from Public Works to get with Ms. Chester to address her questions and concerns.

## 10. BUSINESS OR REPORTS FROM THE MAYOR OR OTHER MEMBERS OF CITY COUNCIL:

Council Member Jones stated that he wants to say thank you to the city council, city employees, the developers, and the different departments throughout the city. He stated that the week before Mother's Day they had a gospel show at the Petersburg Public Library with different bands that came to perform. He stated that he would like to say thank you to Parks and Recreation, the Library and to the City Council for helping to make that happen. He stated that the city council is responsible for everyone's well-being in the city. He asked everyone to make sure if there was a complaint against anyone, that there is paperwork and that you have done all your homework and taken necessary actions.

Council Member Westbrook stated that they have been talking about a lot of speeding in the last couple of months. He stated that he is still seeing a lot of speeding going on but that he hopes that the message is getting out to slow down especially in school districts. He stated that the bridge to Virginia State University is scheduled to be closed down for 10 months. He stated that he wants to have the traffic measured on the use of the Martin Luther King Bridge to get to VSU. He stated that the grass is starting to get tall on Highway 85 near Ward 7. There is some ponding near Defense Road that some citizens are complaining about, and he would like the city manager and public works to be aware of that. He stated that he wants to continue advocating for stop lights and traffic to continue Mr. Richard Stewart Legacy on Pocohontas Island. He stated that Virginia State had 565 students that graduated this past weekend. He stated congratulations to them and also the students at Richard Bland College. Happy Mother's Day to all of the mothers that were celebrated this weekend. He stated that he hopes that Petersburg can be a leader in teaching the youth that guns are not cool. He stated that he hopes that they can continue to advocate for the city's youth and their public speaking on their concerns and ideas. He stated that he does a Male Empowerment Program at Virginia State University. He stated to please go out and vote for the senator and delegate.

Council Member Myers stated Happy Mother's Day to all the mothers. He stated that he does want to say that there are a lot of things going on in the City of Petersburg. He stated that he is happy that the city opened the VCRC which is the Virginia Community Resource Center. He stated that it is combined with veteran services and community services as well. He stated that he attended a class regarding a Narcan drug to use on anyone to prevent opioid overdose. He stated that he encourages all of the council to take the class as well so that they can be prepared to help the citizens. He stated that Petersburg Police Community Resource Center at 32 West Washington. He stated that PAAL will be in the building as well.

Council Member Smith-Lee stated that she hopes that all of the mothers had a wonderful Mother's Day. She stated that Ward 6 will be having a ward meeting at Cool Springs Elementary School in the library at 6pm on Thursday, May 18th. She stated that he also wanted to congratulate the Virginia State University graduates. She stated that it is amazing how that class had to endure two years of COVID, and they got through it. She stated that her great niece was one of the graduates as well. She stated that she would like to also announce that on May 20th at 12noon at St. Stephen's Episcopal Church there is going to be a House of Delegates Forum. She asked everyone to please come out to support them. She stated that she also wants to congratulate six young ladies that are called "Lady Diamond" at Blandford Academy. She stated that they had lunch with the First Lady. She stated that they are trying to make sure that the young ladies and men know that they are worthy to be and do whatever they need to do to stay afloat. She stated that she wanted to congratulate the PACK at Blandford. She stated that they were dressed up in their nice slacks and suits.

Mayor Parham stated that they have a celebrity on council. He stated that Councilwoman Smith-Lee just got inducted into the LINX organization. He stated to everyone to give a round of applause for that. He stated that a week before that she was inducted into the Hall of Fame. He stated that they are proud of all the great work that she does and to keep up the good work.

Vice Mayor Hill stated that he wants to congratulate Councilwoman Smith-Lee again for being inducted in the LINX and all the accomplishments that she has done. He stated that he would like to thank Ward 2 for coming out last Tuesday to the Ward 2 meeting. He stated that he wants to especially thank My Parham who is the Clerk of Circuit Court, Ken Pritchett who is Chairman of Petersburg School Board, Chief Travis Christian and the City Manager, March Altman. He stated that there was a lot of great discussion. He stated that they will try to have meetings at least once a quarter now that Good Shepherd Baptist Church is back open. He stated that he would like to ask all citizens to take care of their lawns since the grass is starting to grow. He

stated that he is excited about public works and the great job that they are doing to keep everything clean under the leadership of Mr. Richard Harriss and his staff. He stated to the public and citizens that if they see anything that goes against the code violations to contact code compliance or contact the Clerk of Council and she will contact council in regard to the issue. He thanked all the employees for all the hard work that they did in the city. He stated that the city is on the move. He stated that it was an honor to read the proclamation for the memorial service for the Petersburg Police Department.

Council Member Myers stated that he would like to say congratulations and that if everyone is not doing anything on Sunday, but to go by Harvest International Baptist Church. Bishop Bonner will be celebrating her 50<sup>th</sup> pastoral year in the City of Petersburg.

Mayor Parham stated today has been a big day. He stated that the city has an entrepreneur sitting among everyone, Councilman Marlow Jones. He stated that Councilman Jones just had a ribbon cutting for his restaurant in Waverly. He stated that he is also about to retire on June 1st to open up more restaurants. Petersburg is the next place that he will open up a restaurant. He stated that Virginia State University commencement just passed, and he wants to congratulate all the graduates. He stated that there are youth in the city who need attention and so the more that they can go into schools and show them that they care and praise them for the good work that they are doing is always beneficial. He stated that he had a good meeting with Stacey Jordan and David Struminger of Virginia Linen. He stated that it was humbling to hear Virginia Linen state that they want to be a part of the mentoring program for the summer. And they want to bring on interns and pay them and show them the jobs at Virginia Linen.

On October 14, 2022, the developer was advised the following from the Zoning Administrator "417 Jefferson Street - TP# 022390008; R-3, Two Family Residence District; Requires Lot frontage of 60' to construct a duplex and minimum of 6,000 sq ft lot area; new construction requires installation of a driveway to accommodate 2 cars. \*\* Tax Assessors records shows a lot of width of 50' X 150' for a total lot area of 7,500 sq ft.; This lot can be approved for a single-family residence as the required minimum lot width fails to meet Sixty (60')."

The Development Agreement shall be referenced as set forth fully in the deed of conveyance of the Property from the City to Properties Remembered. The deed shall include provisions for the reverter described in the Development Agreement.

**RECOMMENDATION:** Staff recommends the City Council make a motion to approve the development agreement by resolution.

NOW THEREFORE BE IT ORDAINED, that the City Council of the City of Petersburg hereby authorizes the City Manager to execute a Pilot Operating Agreement between the City of Petersburg and Bird Rides, Inc. to establish a stand-up electric scooter sharing system within the City of Petersburg.

# PILOT OPERATING AGREEMENT

This Pilot Operating Agreement (the "Agreement") is entered into by and between Bird Rides, Inc., located at 8605 Santa Monica Blvd. #20388 West Hollywood, CA 90069 ("Company"), and The City of Petersburg located at 135 N Union Street, Petersburg, VA 23803 (the "City") as of \_\_\_\_\_\_\_\_, 2023.

## 1. Statement and Purpose

The purpose of this Agreement is to establish interim rules and regulations governing the pilot operation of a Stand-up Electric Scooter sharing system within the City while this Agreement is in effect (the "Pilot"), and to ensure that the Pilot is consistent with the safety and well-being of bicyclists, pedestrians, and other users of the public rights-of-way.

## 2. Scope

This Agreement and its terms apply to any proposed deployment of Stand-up Electric Scooter sharing systems within City's jurisdictional boundaries. This Agreement and the Pilot shall remain in effect for a period of twelve months and shall automatically renew for successive twelve month periods unless either party provides written notice to the other of its intention not to renew at least ninety (90) days prior to the end of the then-current term.

#### 3. Procedures

While this Agreement is in effect, Company shall be the sole provider of Stand up Electric Scooter sharing systems within City's jurisdictional boundaries for the Pilot, contingent upon compliance with the terms of this Agreement. Upon effectiveness of this Agreement, Company shall provide an affidavit of compliance with the terms of this Agreement and provide appropriate indemnification.

## 4. Operating Regulations

- a. Company, and/or its service providers, agents or assigns, shall be responsible for operating a Stand-up Electric Scooter program in the City with the below requirements.
- b. "Stand-up Electric Scooter" shall mean a device weighing less than 150 pounds, that (i) has handlebars and an electric motor, (ii) is solely powered by the electric motor and/or human power, and (iii) has a maximum speed of no more than 20 mph on a paved level surface when powered solely by the electric motor.
- c. Except as otherwise provided herein, City shall regulate the operation of Stand-up Electric Scooters in a manner no more restrictive than City's regulation of bicycles.
- d. Stand-up Electric Scooters are to be ridden on streets, and where available, in bike lanes and bike paths. Stand-up Electric Scooters are to stay to the right of street lanes and to offer the right of

- way to bicycles in bike lanes and on bike paths. Users of Stand-up Electric Scooters shall be 18 or older. Users of Stand-up Electric Scooters who violate these provisions may be fined by City consistent with fines for cyclists.
- e. Company shall provide easily visible contact information, including toll-free phone number and/or e-mail address on each Stand-up Electric Scooter for members of the public to make relocation requests or to report other issues with devices.
- f. Hours of operation when Company's Stand-up Electric Scooters will be made available to rent from 5 a.m. to midnight (local time).

# 5. Parking

- a. Users of Stand-up Electric Scooters shall park devices upright in the furniture zone of the sidewalk, beside a bicycle rack or in another area specifically designated for bicycle parking, or on the street next to an unmarked curb.
- b. Users shall not park Stand-up Electric Scooters in such a manner as to block the pedestrian clear zone area of the sidewalk; any fire hydrant, call box, or other emergency facility; bus bench; or utility pole or box.
- c. Users shall not park Stand-up Electric Scooters in such a manner as to impede or interfere with the reasonable use of any commercial window display or access to or from any building.
- d. Users shall not park Stand-up Electric Scooters in such a manner as to impede or interfere with the reasonable use of any bicycle rack or news rack.
- e. Users may park Stand-up Electric Scooters on blocks without sidewalks only if the travel lane(s) and 6-foot pedestrian clear zone are not impeded.
- f. Users shall not park Stand-up Electric Scooters in the landscape/furniture zone directly adjacent to or within the following areas, such that access is impeded:
  - i. Transit zones, including bus stops, shelters, passenger waiting areas and bus layover and staging zones, except at existing bicycle racks;
  - ii. Loading zones;
  - iii. Disabled parking zone;
  - iv. Street furniture that requires pedestrian access (e.g., benches, parking pay stations, bus shelters, transit information signs, etc.);
  - v. Curb ramps;
  - vi. Entryways; and
  - vii. Driveways.
- g. Users of Stand-up Electric Scooters who violate these provisions may be fined by City consistent with fines for cyclists.
- h. Company may stage its Stand-up Electric Scooters in permitted parking areas as described in this section. To the extent Company desires to stage Stand-up Electric Scooters in areas other than the public right-of-way, Company must first obtain the right to do so from the appropriate City department, property owner, or public agency.

# 6. Operations

- a. Company shall maintain 24-hour customer service for customers to report safety concerns, complaints, or to ask questions. Company shall maintain a multilingual website, call center, and/or mobile app customer interface that is available twenty-four hours a day, seven days a week. The aforementioned shall be compliant with the Americans with Disabilities Act.
- b. In the event a safety or maintenance issue is reported for a specific device, that Stand-up Electric Scooter shall be made unavailable to users and shall be removed within the timeframes provided herein. Any inoperable or unsafe device shall be repaired before it is put back into service.
- c. Company shall respond to reports of incorrectly parked Stand-up Electric Scooters, Stand-up Electric Scooters continuously parked in one location for more than 36 hours, or unsafe/inoperable Stand-up Electric Scooters, by relocating, re-parking, or removing the Stand-up Electric Scooters, as appropriate, within 24 hours of receiving notice that must include the location of the Stand-up Electric Scooter.
- d. Company shall provide notice to all users that:
  - i. Stand-up Electric Scooters are to be ridden on streets, and where available, in bike lanes and bike paths;
  - ii. Stand-up Electric Scooters are to stay to the right of street lanes and to offer the right of way to bicycles on bike lanes and bike paths;
  - iii. Helmets are encouraged for all users;
  - iv. Parking must be done in the designated areas; and
  - v. Riding responsibly is encouraged.
- e. Stand-up Electric Scooter riders are required to take a photo whenever they park their scooter at the end of a ride.
- f. Company shall provide education to Stand-up Electric Scooter riders on the City's existing rules and regulations, safe and courteous riding, and proper parking.

# 7. Data Sharing

City may require Company to provide anonymized fleet and ride activity data for all trips starting or ending within the jurisdiction of City on any vehicle of Company or of any person or company controlled by, controlling, or under common control with Company, provided that, to ensure individual privacy:

- a. such data is provided via an application programming interface, subject to Company's license agreement for such interface, in compliance with a national data format specification such as the Mobility Data Specification;
- b. any such data provided shall be treated as trade secret and proprietary business information, shall not be shared to third parties without Company's consent, and shall not be treated as owned by the local authority; and

c. such data shall be considered personally identifiable information, and shall under no circumstances be disclosed pursuant to public records requests received by the local authority without prior aggregation or obfuscation to protect individual privacy.

#### 8. Indemnification

Company agrees to indemnify, defend and hold harmless City (and City's employees, agents and affiliates) from and against all actions, damages or claims brought against City arising out of Company's negligence or willful misconduct, except that Company's indemnification obligation shall not extend to claims of City's (or City's employees', agents' or affiliates') negligence or willful misconduct. City expressly acknowledges that in no event shall Company be liable for any special, indirect, consequential or punitive damages. Company's indemnification obligations shall survive for a period of one (1) year after expiration of this Agreement. Company shall be released from its indemnification obligations under this section if the loss or damage was caused by the City's negligent construction or maintenance of public infrastructure. City's right to indemnification shall be contingent on City notifying Company promptly following receipt or notice of any claim; Company shall have sole control of any defense; City shall not consent to the entry of a judgment or enter into any settlement without the prior written consent of Company.

## 9. Insurance

Company shall provide City with proof of insurance coverage exclusively for the operation of Stand-up Electric Scooters including: (a) Commercial General Liability insurance coverage with a limit of no less than \$1,000,000.00 each occurrence and \$2,000,000.00 aggregate; (b) Automobile Insurance coverage with a limit of no less than \$1,000,000.00 each occurrence and \$1,000,000.00 aggregate; (c) Umbrella or Excess Liability coverage with a limit of no less than \$5,000,000.00 each occurrence/aggregate; and (d) where Company employs persons within the City , Workers' Compensation coverage of no less than the statutory requirement.

#### 10. Miscellaneous

- a. All notices and communications to the City from Company shall be made in writing (includes electronic communications) and sent to the address below.
- b. In carrying out their responsibilities, the parties shall remain independent contractors, and nothing herein shall be interpreted or intended to create a partnership, joint venture, employment, agency, franchise or other form of agreement or relationship.
- c. This agreement shall be governed by and construed in accordance with the laws of the Commonwealth of Virginia.

WHEREAS, the City of Petersburg recognizes that in 2006, the International Network for the Prevention of Elder Abuse proclaimed June 15th of each year as World Elder Abuse Awareness Day; and WHEREAS, the United States Census Bureau, Population Division's data "2020: American Community Survey (ACS) -year Estimates Subject Tables" prepared by the Crater Planning District Commission, reports that the total number of Virginians aged 60 and older numbers 1,838,379 seniors; and

WHEREAS, according to the Department of Justice (DOJ) Elder Abuse Initiative, elder abuse is an intentional or negligent act by any person that causes harm or a serious risk of harm to an older adult; subtypes of elder abuse include physical abuse, financial fraud, scams, exploitation, caregiver neglect and abandonment, psychological abuse, and sexual WHEREAS, the Virginia Department for Aging and Rehabilitative Services (DARS) reported Adult Protective Services (APS) data for state fiscal year 2022; of the 40,371 reports of adult abuse, neglect or exploitation received through the Adult Protective Services Program, 77 percent of the statewide data were persons age 60 years and older; and

WHEREAS, the majority of the APS reports of adult abuse, neglect or exploitation during fiscal year 2022 were reported by a relative followed by financial institution staff. WHEREAS, the Adult Protective Services Program report indicates that self-neglect is the most common type of maltreatment experienced in Virginia, at 62%; and neglect and financial exploitation, when combined occur in 27% of the

#### **VLS | Vehicle Location System**

All vehicles are pre-loaded with map data so when a Bird enters a predetermined geospeed zone, the Vehicle Location System (VLS) triggers and the vehicle automatically slows



BirdOS, Bird's proprietary operating system is dynamically preloaded with the local GPS feed as the vehicle travels so there are **no data delays** from having to download geolocation data from the cloud.



Map data is **cross-checked against current vehicle location** to pinpoint the precise speed limit, no ride zone or other designation (e.g. permitted parking zone) assigned to that location.





**BACKGROUND:** The Virginia Department of Housing and Community Development (DHCD) established and administers the Acquire, Renovate Sell (ARS) program to create affordable homeownership opportunities for low- to moderate- income (LMI), first-time homebuyers while allowing providers increased discretion over acquisition type, region, and resale. A goal of ARS is to help transform a street, a neighborhood, a community, and a family.

The program is the result of a partnership between DHCD, the primary administrator, and the Virginia Housing Development Authority (VHDA), the financial backing. Providers will acquire undervalued homes that are assessed below market value using their own lines of credit, renovate using ARS funding and other leveraged sources if necessary, and resell the property at fair market value to a first-time homebuyer who is an individual or family who has not owned AND occupied a primary residence within the last three years. Homebuyers must also meet VHDA income limits, however, exceptions to the first-time homebuyer definition as well as higher income limits are available for properties located in Areas of Economic Opportunity (Federal Targeted Areas) in accordance with VHDA income and location guidelines. After the sale of the home, the ARS funding is returned, and the provider uses the net proceeds as program income to reinvest in local, affordable housing efforts and cover a portion of administrative costs. The ARS provider network is encouraged to leverage local, state, federal, and private resources during all three stages of their projects to increase the program's overall effectiveness.

WHEREAS, the ARS provider network is encouraged to leverage local, state, federal, and private resources during all three stages of their projects to increase the program's overall effectiveness; and

WHEREAS, homes being renovated and constructed by Habitat for Humanity and other local entities are currently being targeted as a pilot projects for the program in Petersburg.

NOW THEREFORE BE IT RESOLVED that the City Council of the City of Petersburg hereby endorses the Pilot ARS program in the City of Petersburg.



#### Acquire, Renovate, Sell (ARS)

#### PROGRAM DESIGN

#### Objective

The goal of this program is to create affordable homeownership opportunities for low- to moderate-income (LMI), *first-time homebuyers* by renovating previously *undervalued* homes thus transforming a street, a neighborhood, a community, and a family.

#### **Program Description**

The Virginia Department of Housing and Community Development (DHCD) funded the renovation of foreclosures in Virginia for the past ten years through the Neighborhood Stabilization Program (NSP) and the Virginia Trust Stabilization Program (TSP), but the changing real estate market calls for a more adaptable program. DHCD and the Virginia Housing Development Authority (VHDA) have now partnered to create a program that allows providers increased discretion over acquisition type, service region, and resale: Acquire, Renovate, Sell (ARS).

As partners, DHCD will expand the provider network while conducting grant/project monitoring and financial management, and VHDA has already set aside a minimum of \$5 million in financial backing. Under this program, providers will acquire *undervalued* homes using their own lines of credit, renovate using ARS funding and other leveraged sources if necessary, and resell the property at fair market value to a *first-time homebuyer*.

*Undervalued home*: A home that is assessed below market value. This may include but is not limited to homes that are foreclosed, abandoned, vacant, distressed, investor-owned and economically-challenged, estate/divorce/tax sales, or have suffered years of deferred maintenance.

First-time homebuyer: An individual or family with who has not owned AND occupied a primary residence within the last three years. Homebuyers must also meet VHDA income limits. Exceptions to the first-time homebuyer definition as well as higher income limits are available for properties located in Areas of Economic Opportunity (Federal Targeted Areas) in accordance with VHDA income and location guidelines.

#### Eligible Providers

- Localities (including entitlement areas)
- Local government housing authorities
- Planning district commissions (PDCs)
- Regional/statewide housing assistance organizations or nonprofits serving LMI Virginians

Aug 2019 ARS Program Design

#### Program Design

ARS providers, through their own capacity or through that of their partners, will develop a means to acquire, renovate, and resell undervalued homes to LMI, first-time homebuyers. During all three stages of the project, the ARS provider network is encouraged to leverage local, state, federal, and private resources to increase the program's overall effectiveness. VHDA foreclosures will be eligible for acquisition in this program, and there are no census tract or neighborhood requirements. Additionally, a bi-monthly list of available properties will be emailed to providers.

The provider will acquire properties using their own lines of credit (at least \$200,000 or ability to acquire two houses at once — whichever is greater), and must have a property identified with the intent to bid before submitting a request to earmark funds. Applicants are not required to have a property secured when submitting their application, however, strong applications will have multiple properties identified for potential acquisition. A maximum of \$45,000 in ARS funds will be awarded per project to restore the home to a comparable market state. Substantial reconstruction projects will be considered on a case-bycase basis under this program. The \$45,000 will include \$2,000 for performance deliverables (acquisition: \$500, renovation: \$1,000, resale: \$500) incurred by the provider and \$2,500 for the rehab specialist. The remaining \$40,500 will be available for renovation draws and contingencies. Funding is available through a performance pool on a first-come basis. ARS will not provide administrative/developer fees to the providers, however, ten percent of the net proceeds of the sale can be used towards administrative costs.

The property must be listed at fair market value, and initially marketed to LMI, first-time homebuyers. After 60 days on the market, the property can be sold to any LMI applicant who will occupy the home as their primary residence. The program is designed for the resale of homes and will not contain a rental component. All activities funded through ARS will benefit individuals and families, classified at first-time homebuyers, at or below 80 percent of area median income (AMI) in accordance with VHDA income limits. Exceptions to the first-time homebuyer requirement as well as higher income limits can be made for properties located in Areas of Economic Opportunity (Federal Targeted Areas). Additionally, the provider is required to have access to a HUD-approved housing counselor who will coach the homebuyer before the purchase, and continue to monitor them for one year post-purchase to provide support when needed.

VHDA will provide a down payment assistance (DPA) grant should the homebuyer obtain their first mortgage through VHDA (FHA, FNMA, USDA, VA). The DPA grant does not trigger an affordability period or required payments. ARS will not provide closing cost assistance for the provider or homebuyer; leveraged sources must be utilized for these costs (e.g. VHDA Closing Cost Assistance grants).

Once the sale is complete, the rehabilitation funds (\$40,500) are returned to VHDA, and the provider retains the net proceeds. ARS program income may be used to fund subsequent rounds of this program or similar activities in the future.

#### Oversight and Staffing

The implementation of ARS will require synchronized efforts between DHCD and VHDA. The two organizations have signed an MOU in recognition of each party's responsibilities. DHCD will administer the ARS program to include duties such as oversight, training, technical assistance, fiscal management, and reporting. VHDA will support the program financially. Through regular compliance monitoring, the ARS program manager (DHCD) will ensure that activities are executed within program guidelines. The table below identifies key roles in implementation.

**PURPOSE:** To present elements of a Petersburg Neighborhood Traffic Program

**REASON:** To develop a Neighborhood Traffic Management Program (NTMP) that will improve traffic and reducing speeding in the City of Petersburg.

**RECOMMENDATION:** Public Works recommends that a NTMP be established in the City of Petersburg.

**BACKGROUND:** As a result of speeding being among the top complaints of residents, City Council requested that Public Works evaluate other localities, such as the City of Richmond, to determine their approach to reduce speeding. Public Works has presented several presentations to City Council regarding speeding and some activities have been completed (electronic speed indicator signs, stop signs, & speed studies). The City of Richmond has a NTMP and the City of Petersburghas has started developing its own.



The methodologies and guidelines defined in these sources will be used in conjunction with established engineering best practices to inform the Petersburg Neighborhood Traffic Management Program.



### Petersburg Neighborhood Traffic Management Program

- The City of Petersburg will utilize a comprehensive speed management approach to address traffic calming concerns.
- The comprehensive approach will be defined in the approved Petersburg Neighborhood Traffic Management Program (NTMP).
- Citizens, Council members, and City staff will be able to submit *Traffic Calming Requests* through the approved process.

- Each *Traffic Calming Request* will be taken seriously and will go through the same engineering evaluation process.
- Site visits will be conducted to observe existing conditions, collect geometric data and photo-document the location.
- Crash data as well as any existing traffic speed data and volume data will be reviewed.
- ➤ Preliminary assessments ultimately may lead to a full engineering evaluation of the *Traffic Calming Request*.
- Funding will be identified and allocated for each approved project before it is programmed for design and construction.
