**BACKGROUND:** Since year 1917, the City acquired parcels of property which were used as public schools and collectively referred to hereafter as the "Peabody Campus" or the "Peabody. Section 22.1-125(A) of the Code of Virginia provides that "The title to all school property, both real and personal, within a school division shall be vested in the School Board, except by mutual consent of the school board of a school division composed solely of part or all of a city and the governing body of the city, the title to property may vest in the city.

On June 20, 2018, the School Board adopted a Resolution declaring Peabody to be surplus property and directing that the Chairman do all things necessary to transfer title to the property to the City of Petersburg. It was and remains the belief of both the City and School Board that the title to Peabody is vested in the City, however, certain third parties have attempted to challenge the validity of the City's title to the property citing §22.1-125(A) of the Code of Virginia as the basis.

In order to provide clarity and ensure no further confusion concerning the ownership of the Peabody campus, this Office recommends the recordation of a Quitclaim Deed conveying any interest the School Board may have in the property to the City.

### **RESOLUTION TO AUTHORIZE THE ACCEPTANCE OF THE CONVEYANCE OF A QUITCLAIM DEED FOR PEABODY SCHOOL**

WHEREAS, since year 1917, the City has acquired parcels of property which were used as public schools and collectively referred to hereafter as the "Peabody Campus" or the "Peabody;" and

WHEREAS, §22.1-125(A) of the Code of Virginia provides that "The title to all school property, both real and personal, within a school division shall be vested in the School Board, except by mutual consent of the school board of a school division composed solely of part or all of a city and the governing body of the city, the title to property may vest in the city;" and

WHEREAS, on June 20, 2018, the School Board adopted a Resolution declaring Peabody to be surplus property and directing that the Chairman do all things necessary to transfer title to the property to the City of Petersburg (Exhibit A); and

WHEREAS, it was and remains the belief of both the City and School Board that the title to Peabody is vested in the City; and

WHEREAS, certain third parties have attempted to challenge the validity of the City's title to the property citing §22.1-125(A) of the Code of Virginia as the basis; and

WHEREAS, it is the belief that the recordation of a Quitclaim Deed by the School Board will alleviate any future challenges to the City's lawful title to said property; and

WHEREAS, the School Board has executed such a Quitclaim Deed conveying any interest it may have in the property to the City (Exhibit B); and

WHEREAS, it is the desire of City Council to accept the conveyance of such property in accordance with the requirements of §15.2-1803 of the Code of Virginia.

NOW therefore be it RESOLVED that the City of Petersburg does hereby accept the conveyance of such property and City Council directs the City Manager and City Attorney to take all necessary action to ensure the proper recordation of such conveyance in the Land Records of the Clerk of the Circuit Court.

### <u>AFFIDAVIT OF SCHOOL BOARD</u> CHAIRMAN KENNETH L. PRITCHETT

I, Kenneth L. Pritchett, declare as follows:

- 1. I am over the age of eighteen years and am competent to testify as to the facts declared herein, regarding which I have personal knowledge.
- 2. I have lived in the City of Petersburg, Virginia for over thirty (30) years.
- 3. I was elected in July 2006 to serve as a Ward 3 School Board Member of the Petersburg City School Board.
- 4. I have been continuously serving as an elected member of the Petersburg City School Board since being elected in 2006.
- 5. I have held the position of Chairman for the Petersburg City School Board for over twelve (12) years, and currently serve in that position.
- 6. I am familiar with the Petersburg Circuit Court case styled Peabody Academic Learning and Development Center, Inc., v. City of Petersburg and Petersburg City School Board; Case No.: CL20000800-00.
- 7. The case involves a challenge to the title of the Peabody School Property located at 725 Wesley Street (Tax Map #030-01002) ("Property").

- 8. The School Board does not own the Property and does not object to Peterburg City's asserted ownership of the Property.
- 9. In fact, on June 20, 2018, the School Board adopted a Resolution, declaring the Property a surplus and transferring it to Petersburg City, a copy of which is attached as Exhibit A.
- 10. By email dated September 28, 2018, then-Division Superintendent, Dr. Marcus Newsome, on behalf of the School Board, informed then-City Manager, Ms. Aretha Ferrell-Benavides, of the following:

On June 20, 2018, the Petersburg City School Board adopted the attached Resolution finding that it has no further use of Peabody Middle School and declaring it surplus pursuant to § 22.1-129A of the Code of Virginia. A review of the property records available to us indicates that the property on which Peabody Middle School is situated and [sic] owned by the City. Because the City owns the property, there is no need for School Board to execute a deed transferring title to the City and Peabody Middle School was transferred to the City by operation of law upon adoption of the Resolution.

#### WITNESSETH:

WHEREAS, GRANTOR may hold a property interest in the property known as the

"Peabody School Campus" comprised of parcels located at 725 Wesley Street, Petersburg,

Virginia (Parcel No.: 030130002); and 605 Halifax Street (Parcel No.: 030130005), hereinafter

collectively referred to as "THE PROPERTY", as further depicted in the attached sketch

(Exhibit A).

### 725 Wesley Street (Parcel No.: 030130002)

The property conveyed from Jacob Bulifant to the City of Petersburg, Virginia by deed dated May 18, 1917 (Deed Book 90, Page 291) and described as "All that certain lot or parcel of land, with the appurtenances thereunto belonging (but not the buildings thereon, which are reserved and are to be removed) fronting ninetyseven (97) feet, more or less, on the East side of Jones Street, in Said City of Petersburg, and described on a plat thereof, dated December 12, 1902, made by T.R. Dunn, C.E. recorded with the deed of Eloise S. Wells to said L.W.T. Bulifant, dated December 15<sup>th</sup> 1902, in Deed Book No. 66, at page 154, as follows, to-wit: - Beginning at a branch, the rear boundary of the lot hereby conveyed, and running thence Southwardly up said branch thirteen and one-half (13-1/2) feet; thence North 80° West three hundred and seventy three (373) feet to Jones Street; thence Northwardly along the East side of Jones Street ninety-seven (97) feet; thence North 74° East sixty-five and four-tenths (65.4) feet; thence North 20-1/2° East one hundred and twelve and six-tenths (112.6) feet to an iron pin; thence South 80° East three hundred and nineth-six (396) feet to said branch; thence Southwardly along said branch as it meanders to the point of beginning; and

The property conveyed from Alease Drumgoole Swann and Fred Swann, her husband, and Robert J. Wrenn, widower of Corinda Wrenn, deceased, Faith Wrenn Johnson, divorced, Thelma Wrenn Smith and Percy S. Smith, her husband, Robert Hugo Wrenn and Dorothy Smith Wrenn, his wife, and Hiawatha J. Wrenn, and Bernice T. Wrenn, his wife to the City of Petersburg, Virginia by deed dated November 8, 1948 (Deed Book 168, Page 167) and described as "All that certain lot or parcel of land with the improvements thereon and appurtenances thereto belonging, lying and being in the City of Petersburg, State of Virginia, and situate in the rear of the property known as No. 528 Cedar Street, and described by metes and bounds as follows: Beginning at a point on the eastern line of the said property One Hundred (100) feet south of the southern line of said Cedar Street; thence along a line in a westerly direction parallel to the southern line of the said Cedar Street Twenty-five (25) feet more or less, to a point; thence along a line in a southerly direction One Hundred Seventy (170) feet, more or less, to a point; thence along a line in an easterly direction Twenty-five (25) feet more or less, to a point; thence along a line in a northerly direction One Hundred Seventy (170) feet, more or less, to the point of beginning. Being the southern portion of the property which was conveyed to the said Thomas Drumgoole and Mary Drumgoole, his wife, by deed dated May 30, 1892, from Rosetta Hill, unmarried, of record in the clerk's office of the Hustings Court of the City of Petersburg, Virginia, in Deed Book 57, page 601; reference to which said deed is hereby made."

The property conveyed to the City of Petersburg, Virginia via Commissioner's Deed dated August 4, 1949, (Deed Book 169, Page 356) and described as the lot or parcel of land "Beginning at a point in the western line of Federal Street, said point being one hundred (100 feet south of the south line of Cedar Street; thence along the west line of Federal Street south 22° 45' west, sixty (60) feet to a point; thence north 77° 15' west, one hundred and sixty (160) feet to a point; thence south to the point of beginning.

NOW, THEREFORE, for and in consideration of the sum of ONE DOLLAR (\$1.00), receipt of which is hereby acknowledged, the GRANTOR does hereby release, remise, and quitclaim unto GRANTEE all of its right, title, and interest in and to the hereinafter described land, all of which lies in the City of Petersburg, Virginia.

WITNESS that the undersigned GRANTOR Petersburg City School Board executes this conveyance of any and all interest in THE PROPERTY unto GRANTEE in accordance with the Resolution adopted by the Petersburg City School Board dated June 20, 2018 (**Exhibit B**), and in accordance with Resolution No.: \_\_\_\_\_\_\_ adopted by Petersburg City Council on the \_\_\_\_\_\_ day of \_\_\_\_\_\_\_, 20\_\_\_\_ (**Exhibit C**), GRANTEE by joining in this deed through signature of its authorized representative, accepts, as is, the interest in real estate conveyed by this deed pursuant to §15.2-1803 of the Code of Virginia.





### AN ORDNANCE TO AMEND AND RE-ADOPT THE PETERSBURG CITY CODE TO ADD CHAPTER 21 TO CREATE AN "ARTS COUNCIL."

WHEREAS, City Council desires to develop a commission comprised of Petersburg citizens to be known as the "Petersburg Area Arts Council" to assist City Council and make recommendations to Council regarding public art acquisitions, grants, transfers, and purchases; and

WHEREAS, Council believes that the formation of such an advisory board will be in the best interests of the City of Petersburg and assist in the beautification of the City and fostering of art throughout the City.

**NOW THEREFORE BE IT ORDAINED** that the Petersburg City Code is hereby amended and readopted to include Chapter 21 – Arts Council as follows:

### **CHAPTER 21 – ARTS COUNCIL**

### Sec. 21-1. Creation and Purpose

There is hereby created the "Petersburg Public Arts Council" (hereinafter "PAAC"). The purpose of the Public Arts Council is to make recommendations to City Council and City Management on the acquisition, donation, commission and/or funding of public art and the acceptance of gifts and loans of public art and the deaccession of public art from the city's collection.

### Section 1.1. Terms of Office: Filling Vacancies in Office.

The members of the PAAC shall be appointed by the city council and shall serve two (2) year terms. Members are eligible for re-appointment and may serve up to three (3) consecutive terms (for a total of six years of service on PAAC). The first appointments will be staggered with one at- large member appointed for one year and the other at large member appointed for two years. The remaining seven members shall be appointed one for each ward based either upon their residence or business location in the respective ward that they serve. The public art council members must be residents of the city or represent a business or an arts non-profit located in the city of Petersburg. The public art council shall consist of nine (9) members and be composed of the following representatives: at least three (3) practicing artists, at least two (2) members belonging to an arts or culture organization, at least two (2) members associated with design and historical architecture. No member who has served three complete terms shall be eligible for reappointment until after a lapse of an intervening period of one year.

# Section 1.2 Organization powers and duties; officers; powers and duties enumerated.

The members shall meet and organize by the election of a chairman, a vice chairman, and a secretary. They shall make and adopt such bylaws, rules and regulations of their own guidance as may be expedient and may not be inconsistent with this article or resolution, rules or regulations prescribed by the city council.

The public art council shall:

- a. Make recommendations to City Council regarding the acquisition, donation, commission, and or funding of public art and advise the city council on the acceptance of gifts and loans of public art and deaccession of public art from the city's collection.
- b. Make recommendations to City Council and the City's Administration on policies regarding determination of artist qualifications, specific site attribution criteria, maintenance of public art, and develop plans for the further implementation of a public art program.
- c. Maintain an inventory, a proposed maintenance plan, and proposed deaccession plan for city owned public art.
- d. Assist the City in administration of public art grant programs on behalf of the city.
