- Develop a strong foundation for the community's urban forestry program.



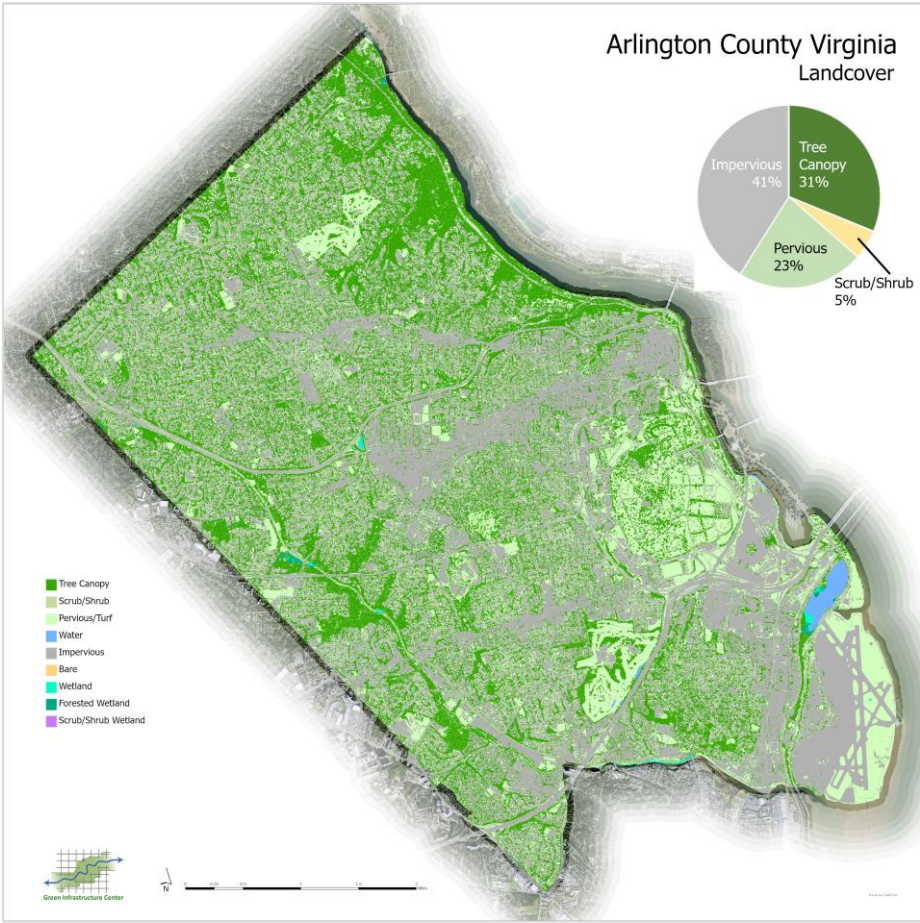

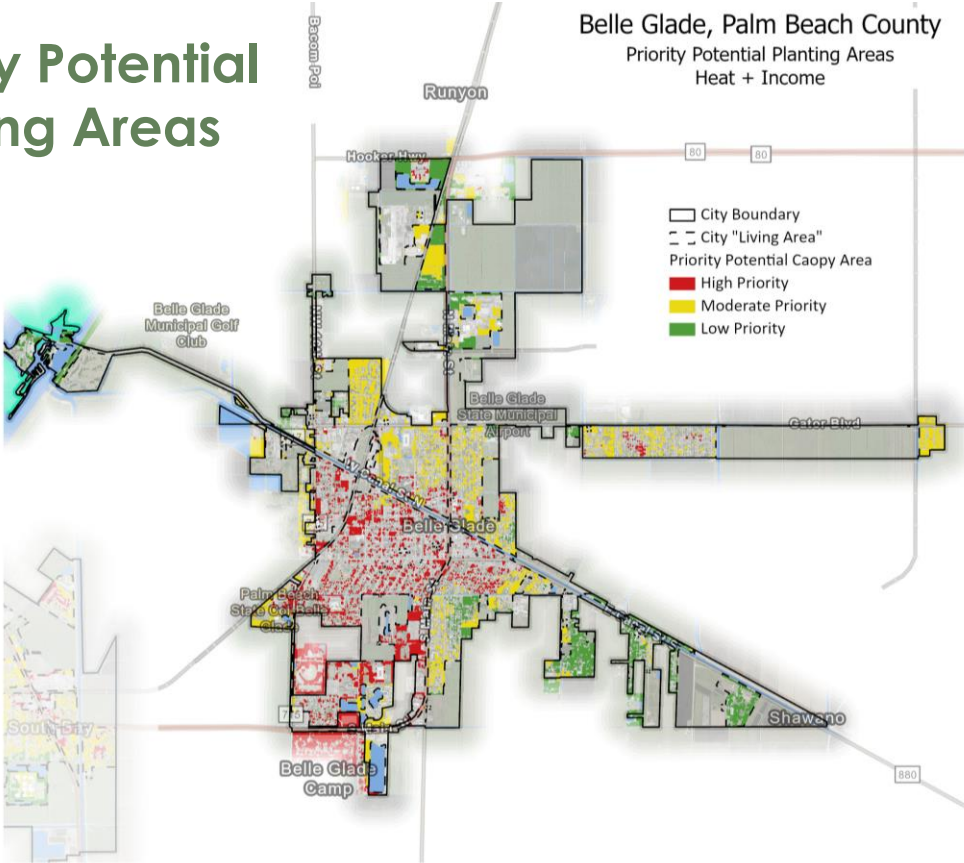

Priority Potential Planting Areas



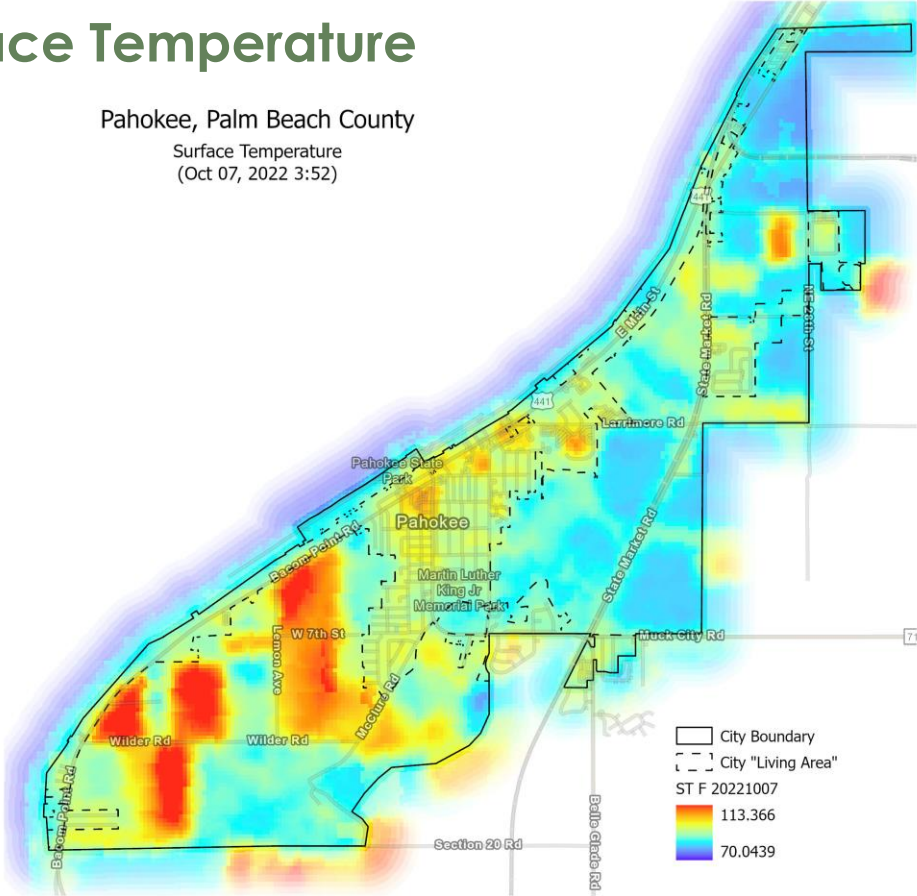
GIC's PPA priority setting method uses indicators such as Surface Temperature, Median Household Income, Rainwater retention and other themes to rank the importance an area might have to gain tree canopy or impacts it would have if three canopy was lost.

Method for creating Priority Planting areas:
MHHI was ranked from 1 to 5 (Lowest Income areas as priority 1)
Surface temperature was ranked from 1 to 5 (Highest Temp priority 1)
The MHHI Rank and ST Rank was then summed and then broken into 3 Natural Breaks based on that score.

Surface temperature data from Landsat Satellite imagery at 30 meter pixel resolution



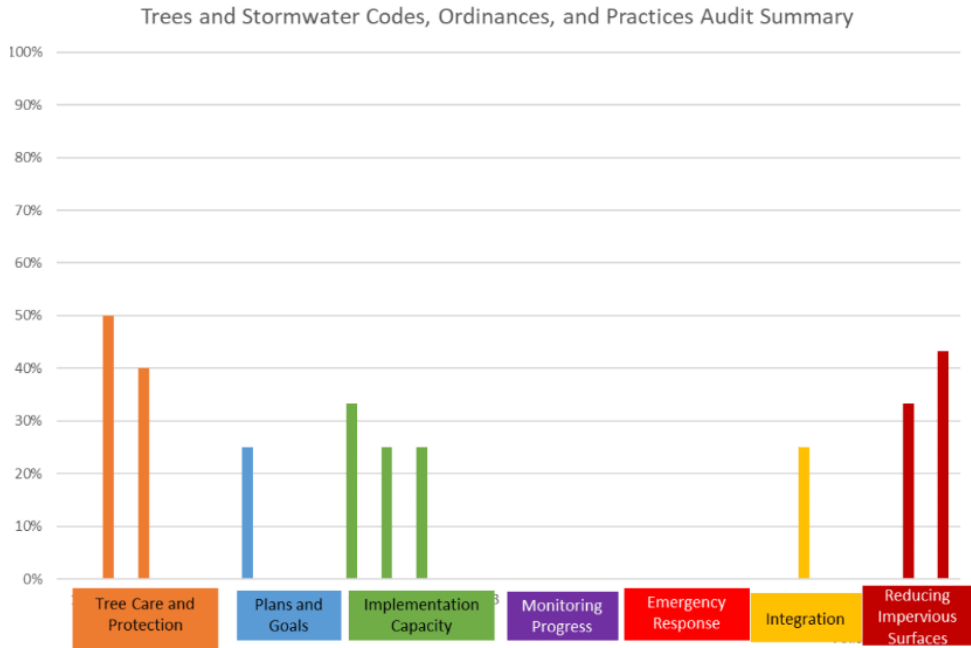
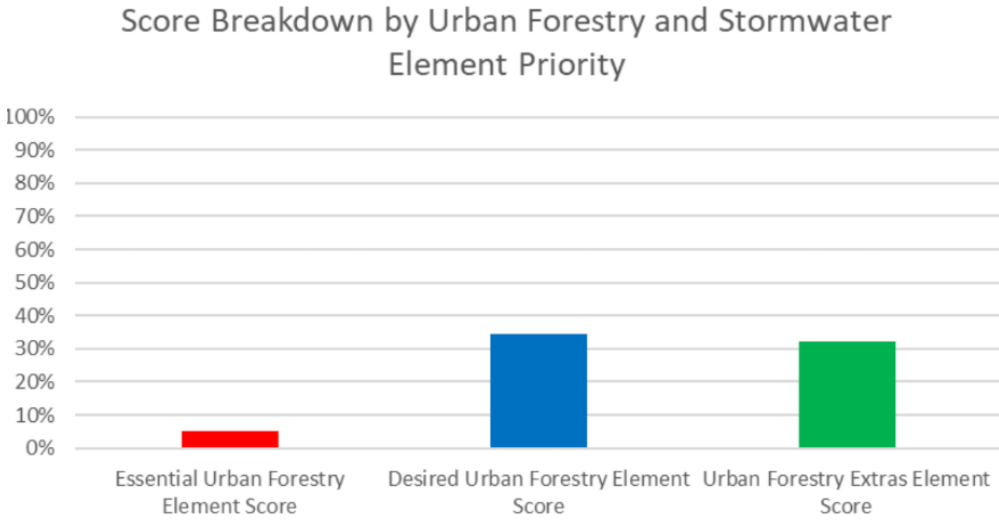

- **Southside Depot**
 - Original scope of work -Structural repairs to joist, HVAC, wood flooring, stair repair, thermal insulation, painting, pointing of bricks amongst others.
 - Projected completion Apr/May 2024*
 - Awaiting scope of work for vault demolition



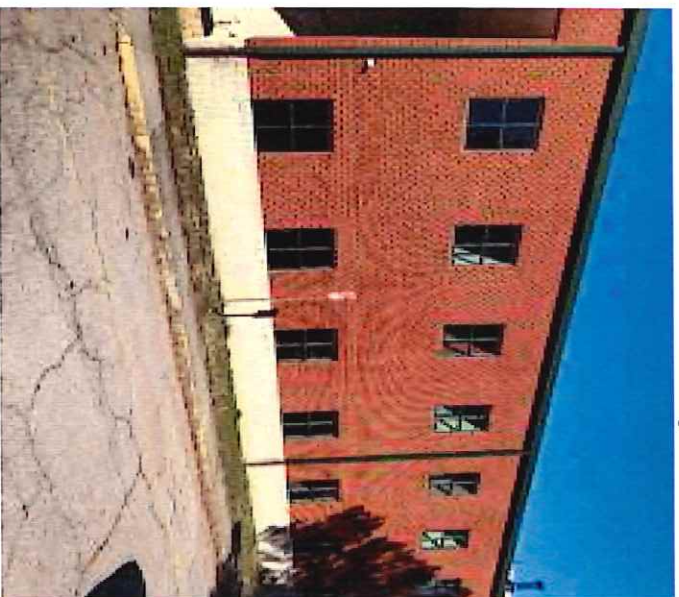

- **Farmer Street Safety Building (Old Social Services Bldg.) – Phase I**
 - Original scope of work - Renovating the exterior of the building (metal stud & sheathing, brick repairs & mortar point up, flashing installations, seal coat of masonry, glazing replacement) & the additional scopes of added glass block and window trim repairs.
 - Phase I completion date January 2024*
 - Additional upcoming items – permanent security fencing around property & lighting for exterior wall packs



** - date dependent on the delivery of the special paint & weather temperature; additional items may extend completion date.*

- **Annual Paving**
 - Capital budget includes \$1.5 mil. for paving in FY24
- **S. Crater Road Signal Improvements (Ward 2; CMAQ funding \$2.0 mil.)**
 - Original scope of project - Project is to update the traffic signals on S. Crater Rd. at Flank Rd., Wagner Rd., Crater Cir, Medical Park Blvd., and Rives Rd. to improve traffic flow, reduce congestion and improve air quality.
 - Project advertised in Jul. 2023 & no bids were received
 - Invitation For Bid (IFB) readvertised on Oct. 25, 2023 & bids due Dec. 5, 2023
 - If bids are received and a contract is executed in Jan 2024 construction could start by Feb/Mar 2024 with a completion date of approximately Sep 2025

Capital Projects, Engineering, Traffic & Transportation



- **S. Sycamore St. Culvert Rehabilitation (Wards 4 & 5; VDOT SGR funding \$616k)**
 - Original scope of project – Project is to rehabilitate the existing box culvert that carries Lieutenant Run under S. Sycamore St. & located just to the north of I-85. The existing box culvert is approximately 85 years old & requires concrete repairs, erosion repairs & tree removal.
 - Project has been delayed due to environmental review by VDOT and then by the Federal Highway Administration.
 - In the interim Kimley-Horn is working on project design.
- **Locks Watermain Replacement**
 - Project manual containing technical specifications completed by Timmons Group
 - Purchase requisition prepared
 - Both to be submitted to Purchasing on or before Dec 8. for IFB
- **Prince George Water System Interconnection (O&M Project)**
 - Project manual containing technical specifications completed by Timmons Group
 - Purchase requisition prepared
 - Both to be submitted to Purchasing on or before Dec 8. for IFB



- **Citywide Drainage Study**
 - Stormwater infrastructure inventory approximately 70% complete
 - Community Outreach Program underway (starting “Ward Meeting” phase of outreach)
 - Expected Completion Jun. 2024 (high impact areas will be prioritized and developed into potential projects first)
- **Stormwater/Drainage Improvement Projects**
 - North Whitehill Drive Drainage Improvements (Phase 1 – Green Infrastructure/Phase 2 – Grey Infrastructure):
 - Phase 1 Design complete (Grant- & City-Funded); Securing easements to enter Construction Bid Phase (Jan. 2024)
 - Phase 2 Design (ARPA Funded) – To be completed during Phase 1 Construction (CFPF Funded)
 - Expected Project Completion: Phase 1 – Apr. 2024; Phase 2 – Jun. 2025
 - Claremont Drainage Repair/Replacement: Final project scoping pending; Expected Completion: Sep. 2024
 - Fleets Branch Stream Restoration (Grant funded thru NFWF/DEQ-SLAF/ARPA):
 - Design plans complete
 - MOU execution/final signature pending to enter Construction Bid Phase
 - Expected project completion Dec. 2024

 - Expected project completion for maintenance work Jun. 2024
 - Expected project completion for overall construction Jun. 2025
 - Shirley Avenue Stream Restoration:
 - Project extended for additional pollutant removal (ROW/easement impacts)
 - Original Project: DEQ-Grant Awarded
 - Project Extension: DEQ-SLAF Grant Application Submitted (award in Jan. 2024)
 - Two Site Visits w/DEQ Completed
 - On-site Sewer Crossing Investigation Needed/Underway

- a. 2. **PRAYER:**

Mayor Parham stated that Vice Mayor Hill will lead the city council meeting in the opening prayer. He asked to include in the prayer Israel.

Vice Mayor Hill led the city council meeting in the opening prayer.

3. **PLEDGE OF ALLEGIANCE:**

Mayor Parham led the council and the citizens in the pledge of allegiance.

4. **DETERMINATION OF THE PRESENCE OF A QUORUM:**

A quorum was determined with the presence of all city council members.

5. **PROCLAMATIONS/RECOGNITIONS/PRESENTATION OF CEREMONIAL PROCLAMATIONS:**

- a. Presentation on Street Operations Division: Petersburg Neighborhood Traffic Management Program.

Mr. Altman stated that back in the summer there was a work session on the topic, and it was requested to provide an overall procedure of the traffic management program to the November meeting. He stated that this evening Mr. Reggie Lantz will be providing an update and presentation on the program.

Reggie Lantz, General Manager of Public Works and Utilities, gave a PowerPoint presentation on the traffic program.

Key Notes:

- The methodologies and guidelines defined in these sources were used in conjunction with established engineering best practices to inform the development of the Petersburg Neighborhood Traffic Management Program. The information is derived from the successful traffic calming programs existing in the City of Richmond, Henrico County, and the City of Charlottesville, VA, were also considered for inclusion in the manual.

- The City of Petersburg will utilize a comprehensive speed management approach to address traffic calming concerns.
- The comprehensive approach is defined in the approved Petersburg Neighborhood Traffic Management Program (NTMP).
- Citizens, city staff, and council members will be able to submit Traffic Calming Requests through the approved process.
- Each Traffic Calming Request will be taken seriously and will go through the same engineering evaluation process.
- Site visits will be conducted to observe existing conditions, collect geometric data and photo-document the location.
- Crash data as well as any existing traffic speed and volume data will be reviewed.
- If a project is deemed appropriate, then funding must be identified and allocated for each approved project before it will be programmed for design and construction.

There was a discussion between the city council members and staff.

Vice Mayor Hill stated that he has one request regarding the stop sign on Bollingbrook and Sycamore Street. He stated that since the light has been removed and a stop sign has been put their people are continuing to run the stop sign. He asked if they could look at putting the light back there. He stated that it was an accident there this past week and someone ran through the stop sign and hit a car that was turning.

It was also requested by the city council to look at the streets throughout the city because there are areas that need major repaving.

8. OFFICIAL PUBLIC HEARINGS:

- a. A public hearing on an appeal by John Brockwell, applicant of 21 West Washington Street, Tax Parcel 022-03-0001, owned by Labrodor Properties LLC/John Brockwell, on the decision of the

Architectural Review Board (ARB). The property is located within the Courthouse Local Historic District.

BACKGROUND: Mr. Brockwell applied for a Certificate of Appropriateness (COA) on August 24 with a request to remove the standing seam metal roof on the easternmost gable roofed section of this building and replace it with TPO. The rest of the roof is flat and not visible from the public right-of-way, but the section in question is and is therefore subject to review by the ARB. The application was heard at the September 13, 2023, ARB meeting and denied as submitted based on the Design Guidelines Chapter 4 Section F. An appeal of this decision was received by the Clerk of Council on May 12, 2022, requesting that City Council overturn the ARB's denial.

RECOMMENDATION: Staff recommend that the City Council uphold the decision of the ARB.

Naomi Siodmok, Director of Planning & Community Development, gave an update on the request.

Mayor Parham opened the floor for public comments.

Joe Battiston (Chair of Architectural Review Board), 1 South Sycamore Street, stated, "The Architectural Review Board has National Parks and Department of Interior Virginia State Association that we have to follow guidelines and rules. Roofs are important on historic buildings. Everyone tries to put on a less expensive roof whenever they can. We are not able to look at the expense part of when we are dealing with the historic properties. Especially when it is a rule. When there is a guideline, it is more flexible. Roofs are not a guideline they are a rule. So, we have things that we have to follow. We are able to flex on slate roofs now according to the Department of Historic Resources to use synthetic slate roofs. But when it comes to changing from a standing roof to either the same type of material they requested or a shingle roof we have to say no. That is one of the rules that we have to follow. This particular property is on one of our major roads. The thing is that I know that the city is looking into doing a two-way on Washington Street and a two-way on Wythe Street again. If this were to happen this building would be in the sight line of any traveling east on Washington Street. So, we actually had to turn down the request to put TPO on the building. I am asking that you uphold our decision on that because we did not have any latitude with it. It is a rule. Thank you very much."

Seeing no further hands, Mayor Parham closed the public hearing.

Council Member Cuthbert made a motion to uphold the decision of the Architectural Review Board.

Mayor Parham stated, "Council Member Cuthbert can we hold that motion for a second, I know Council Member Jones had a question."

Amanda Greene, 301 Rolfe Street, stated, "Good evening and Happy Holidays. I just wanted to bring to your attention the dumping around Pocohontas Island. In October, I observed a gentleman and his daughter come onto the island and dump several TVs over at the Appomattox River Heritage Trail. I took pictures and sent it to Cuthbert along to Mr. Christian in the police department so that we can try to pursue them and charge them with littering. I know that Mr. Cuthbert came by the island recently and I was in Canada. But those TVs are still out there and now someone has dumped tree limbs out there as well. I know a while back some folks had mentioned that they closed the gate over there by the Appomattox River Trail by Maagazine Road to prevent dumping. Which is not helping because it is closed, and people are still dumping. Also, I can no longer access the trail because of the gate, which I can jump it, but it would not be safe. And that is very unfortunate for us to have to deal with that. I am going to ask that we install cameras over there by that entry point. Even if we did not put cameras over there, we can put signs or something. This way it discourages and prevents people from coming to dump things. Also, in the Appomattox River Heritage Trail there are overgrown limbs and I know that it is city owned property. I do not think that anyone is paying attention to the fact that there are trees that fell in June that no one has picked up. The other thing that I want to bring up is the nonconforming uses in the city. And when I say that I know that nonconforming uses speak to something that may have been legal in the past and now it has changed because of some amendments. However, there are two properties, one on 323 Rolfe Street, and 324 Rolfe Street. Both are currently being utilized for commercial storage. The final thing I want to speak about is the property that I moved my mom into on High Street, 126-08 West High Street. I put in several complaints with the city as it relates to overgrown grass and the house is just dilapidated. It is very surprising that the house has not been retagged. But I did want to commend the police department. I was riding down Wythe Street and I was speeding, and I got a letter in the mail that was a warning letter. So, I just want to say that is making people aware of what they are doing. Thank you very much."

10. BUSINESS OR REPORTS FROM THE MAYOR OR OTHER MEMBERS OF CITY COUNCIL:

Council Member Cuthbert stated that he is holding a Ward 4 meeting and that he has to check his calendar for the correct day. He stated that it will be next week and that they can keep an eye on the

newspaper for more information. He stated that it will be held at St. Mark's Church at 6:30pm. He stated that he hopes that the public can attend and that the topics are security and blight. He stated that he hopes that the city manager can attend.

Council Member Jones stated that he would like to say thank you to everyone that works for the City of Petersburg and for putting in hard work. He stated that he asks that if the employees can do more, please do more and keep the pride up in the city. He stated that he would like to ask the city manager if he would consider tomorrow being a full off day for the city employees versus a half a day.

Council Member Jones made a motion to give city employees a full day off on Wednesday, November 22, 2023, versus a half a day. Council Member Myers seconded the motion. There was discussion on the motion. The motion was approved on roll call vote. On roll call vote, voting yes: Jones, Myers, Westbrook, Hill, and Parham; Voting No: Cuthbert

Council Member Jones stated that he will be having two Ward Meetings on December 16th. He stated that one will be in Pin Oaks and one in Petersburg East Apartments. He stated that the topics will be mindset and violence. He stated that he will be presenting something to the city council on the empty trailers on vacant lots throughout the city. He stated that there is a free semi-pro football game with the Petersburg Lions Semi-professional team coming out of retirement playing against the Richmond Jets at Albert Jones football field to kick-off. He stated that it is at 2pm and everyone is invited to come out and attend the game. He stated that he is celebrating his first year on city council and he has all kinds of gray hair on his chin. He stated that everyone may see him, and Council Member Cuthbert goes at it, but it is no offense to him. He stated that he is just passionate about what he says and does. He said Happy Holidays to everyone.

Council Member Westbrook stated that he is going to stick to giving seven points. He stated that he was able to represent City Council in Atlanta at the National League of Cities conference. He stated that one of the biggest takeaways is Artificial Intelligence (AI). He stated that AI was a big topic at the conference. He stated that he spoke with the city manager regarding this and that they will follow-up over the next couple of weeks into the new year. He stated that Virginia State university made history yesterday by becoming the host of the Presidential General Election Debate on October 1st. He stated that he hopes that with Ms. Joanne Williams and staff help that Petersburg will be at the table and play a major part with the world. He stated that he would like to congratulate the Petersburg Forensics Team on their accomplishments. He stated on December 9th Ms. Teri Smith will be hosting the tournament. He stated Happy 112th Founders Day to the omega Psi Phi. He asked if he could be provided with a leaf pickup schedule from public works. He stated that the leaves are falling, and he has not seen any information on when pickups will take place. He stated that a Ward 7 resident Sgt First Class Lee also passed away and his funeral was yesterday. He stated that he would like to recognize him for the service that he did. He said Happy Thanksgiving to everyone.

Council Member Myers said Happy Thanksgiving to everyone. He stated that he received a call the other day and there is a situation that is going on in Petersburg and in other jurisdictions. He stated that there is a woman that lived 50 years in her home, and she is 80 years old. He stated that the previous owner sold the home, and the new owner is giving her 30 days to be out, and she has a fixed income. He stated that it has been hard for the family to find somewhere else for her to go because she only has 30 days to vacate. He stated that it also comes back to what Ms. Howard came to us about with the city in the process with collections. He stated to the city manager that he brought this information forward in hopes that he would still be working on that process for them. He stated that he cannot see how any individual, whether they purchased the house or not for investment purposes that you would put an 80-year-old woman out in the streets in 30 days.

Council Member Smith-Lee stated that she wants to send out her condolences to the Leroy Folks Family in Cool Springs. She stated that he and his wife were mentors to her and her siblings. She stated that he passed away and he was a veteran and a good man. She stated that he worked at the Petersburg Post Office. She stated that she wants to congratulate Teri Hill on being teacher of the year for Petersburg High School. She stated that she wanted to congratulate and thank the principal at Walnut Hill Elementary School, LaTonya Oliver. She stated that Walnut Hill has the best attendance in the City of Petersburg of all the schools.

She stated that she wants to congratulate the middle school girls' basketball team. She stated that she would like to congratulate Christopher Fields who played basketball for Petersburg High School. She stated that he is now a starter for Norfolk State University. She stated that she would also like to congratulate the Class of 1993 for their 30th class reunion. She stated that they had an awesome event. She stated that the last thing is that she wants to congratulate the new baby that is coming with Mrs. Lucas. She stated to Mrs. Lucas that on behalf of the city council, city manager and everyone congratulations and Godspeed for a healthy baby.

Proposed improvements include high-visibility crosswalks, pedestrian signal poles and push buttons (where applicable), and curb ramps with detectable warning surfaces. A pedestrian hybrid beacon is proposed at the midblock crossing locations. A raised pedestrian crossing is proposed at the midblock crossing on Sycamore Street.

The total funds requested are \$2,728,549. No match is required.
